- a citizen of the United States of America
- at least 18 (eighteen) years of age to qualify for office
- able to read and write
- a resident of the district, or of such constituent district of a consolidated or regional district as may be required by law, from which he/she is to be elected for at least one year preceding the date of the election
- not disqualified as a voter pursuant to N.J.S.A. 19:4-1
- a registered voter in the district
- not convicted of a disqualifying crime pursuant to N.J.S.A.18A:12-1

No board of education member shall be directly or indirectly involved in any contract with, or claim against, the board.

## **IMPORTANT INFORMATION**

- Within 30 days of election or appointment to the board, a member must undergo a <u>criminal history background investigation</u> through the New Jersey Department of Education.
