QUALIFICATIONS - Candidates filing a nominating petition for board membership must meet the following qualifications:

- a citizen of the United States of America
- at least 18 (eighteen) years of age to qualify for office
- able to read and write
- a resident of the district, or of such constituent district of a consolidated or regional district as may be required by law, from which he/she is to be elected for at least one year preceding the date of the election
- not disqualified as a voter pursuant to *N.J.S.A. 19:4-1*
- a registered voter in the district
- not convicted of a disqualifying crime pursuant to *N.J.S.A. 18A:12-1*

No board of education member shall be directly or indirectly involved in any contract with, or claim against, the board.

IMPORTANT INFORMATION

- Within 30 days of election or appointment to the board, a member must undergo a **criminal history background investigation** through the New Jersey Department of Education.
- The School Ethics Act and nepotism legislation impact the ability of board members who have relatives working in the school district to act in areas such as personnel and collective negotiations. Please consult your board secretary for details.
- Two or more candidates for any given term of office may notify the secretary of the board in writing at least seven days before the drawing date that they wish to have their names with their chosen designation, if any, bracketed together, so that their names and designation, if any, are selected as a group at the drawing and their names and designation are printed together on the ballot. The candidates shall determine among themselves the order in which their names are to appear within the bracket prior to so notifying the secretary. *N.J.S.A. 19:60-8(d)*.

(Note: County clerks are encouraged to fill out this section prior to distribution to school board candidates.)

Completed nominating petitions shall be filed with the county clerk on or before 4:00 p.m. on the last Monday in July, which is **July 28, 2025**, for the General Election.
