EGG HARBOR CITY BOARD OF EDUCATION REORGANIZATION/REGULAR MEETING

January 4, 2017

The reorganization/regular meeting of the Egg Harbor City Board of Education was held on the above date at 7:00 p.m. at the Egg Harbor City Community School, 730 Havana Avenue, Egg Harbor City, New Jersey, with Business Administrator, Joseph Smurlo opening the meeting, and board members, Stephen Bouchard, Janine Caudo, Stephen Murphy, Steven Ortiz, Mary Ann Rogers and Dana Seaver present. Also present was: Superintendent/CLS Principal, Adrienne Shulby; Supervisor of Early Childhood/LDTC, Tara Macchione; Board Solicitor, Ron Sahli; and Board Secretary, Maryanne Shupin.
