EGG HARBOR CITY BOARD OF EDUCATION REGULAR MEETING

February 8, 2012

The regular meeting of the Egg Harbor City Board of Education was held on the above date at 7:00 p.m. at the Egg Harbor City Community School, 730 Havana Avenue, Egg Harbor City, New Jersey, with President Stephen Bouchard opening the meeting, and board members, Michael Beaulieu, Janine Brown, Rick Dovey, Scott Senn and Jeanne Williams present. Also present were: Superintendent, John Gilly III; Business Administrator, Joseph Smurlo; Supervisor of Special Projects, Gina Forester; Spragg Principal, Adrienne Shulby; Community School Principal, Jack Griffith; and, Board Secretary, Marie Setterman.

Mr. Bouchard called the meeting to order at 7:00 p.m. with the following statement:

Mr. Bouchard called for the flag salute and roll call, which is reflected in the opening paragraph.

SPECIAL PRESENTATION

Third grade teacher, Debbie Rollins presented the Board with the Kids Walk Longevity Award that the Spragg School received for the 2011 Walk to Cure Diabetes. Mrs. Rollins said that this is the fourth year that the Spragg School has participated in the walk with goals of teaching students about diabetes and healthy eating and also to raise money to help Type I diabetes research and awareness of juvenile diabetes. Mrs. Rollins said that the walk has raised over \$8000 over the last four years.
