EGG HARBOR CITY BOARD OF EDUCATION REGULAR MEETING

March 2, 2011

The regular meeting of the Egg Harbor City Board of Education was held on the above date at 7:00 p.m. at the Egg Harbor City Community School, 730 Havana Avenue, Egg Harbor City, New Jersey, with President Stephen Bouchard opening the meeting, and board members, Joseph Farnan, Scott Senn, and Jeanne Williams present. Also present were: Superintendent, John Gilly III; Business Administrator, Joseph Smurlo; Supervisor of Special Projects, Gina Forester; Spragg Principal, Adrienne Shulby; Community School Principal, Jack Griffith; and, Board Secretary, Marie Setterman.

Mr. Bouchard called the meeting to order at 7:00 p.m. with the following statement: In compliance with the N.J.A.C. 5:18-3.15, in case of fire or other emergency, which should cause this facility to be evacuated, I direct your attention to the location of the exits in this facility. Also, there will be no smoking in this facility. This is to advise those present at this meeting of the Board of Education of the Egg Harbor City School District, in the County of Atlantic, that adequate notice has been given of this meeting as required by the provisions of Chapter 231 of the Laws of 1975; that notice thereof has been forwarded for publication in the District official newspapers, posted in the Spragg and Community Schools, and forwarded to the Egg Harbor City Clerk within the time required by said Act.

Mr. Bouchard directed the secretary to enter this public announcement into the minutes of this meeting.

Mr. Bouchard called for the flag salute and roll call, which is reflected in the opening paragraph.

EXECUTIVE SESSION

There was no executive session.

OPEN TO THE PUBLIC

There were no public comments.

COMMENTS FOR THE GOOD OF THE BOARD

There were no comments.

MONTHLY REPORTS

Mr. Gilly and Mr. Smurlo explained the budget as it would be submitted to the Atlantic County Office of Education.

Mr. Gilly said he has had two meetings with GEHR school district officials, City Council officials, SDA officials, TVS officials, Polistina and Associates officials, Pinelands officials and Cape Atlantic Soil Conservation District officials regarding the detention basin in front of EHCCS. The basin is meant to drain in 72 hours and is a current requirement of the NJ Pinelands Commission. Mr. Gilly said that when the school was designed this was not a requirement and therefore was not designed properly and reiterated that regardless of the previous Pinelands regulations, water surrounding the elementary/middle school presents a health, safety and welfare issue/concern for the district.

Mr. Gilly said the Rittenberg equipment/furniture give-away on Saturday, February 26th, for Egg Harbor City residents went well.

Mr. Gilly reminded the board that the Superintendent evaluation process is ready to begin. Mr. Gilly said he will complete his section of the evaluation online by the end of this week and the Board will then be notified to complete the next step in the evaluation process.

Mr. Gilly and the Board discussed the solar project saying that the project is currently at a standstill. The Board must decide what steps to take.

Mr. Gilly gave Board members a letter from Atlantic County Superintendent Tom Dowd inviting any Board members interested in serving on the Atlantic County Professional Development Board to contact him.

Mr. Smurlo explained the financial items on the agenda tonight.

Mrs. Shulby said that Spragg is celebrating Read Across America and Dr. Suess's birthday all week with green eggs and ham lunch, celebrity readers and visitors.

Mrs. Forester commented that the Child Team members were very happy with the space they have in their new offices and are now able to provide the students with needed services.

Mr. Griffith said that he has been meeting with Mrs. Burzo regarding the Memorial Wall that is located in the hall just outside the library. It is a large wall and he would like to work on it in increments beginning with memorializing African American educators from the White Horse Pike School, noting that Mr. Cliff Mays had requested this early last year. Mr. Griffith said that he would like to form a committee and that the Board would receive an email regarding this soon.

Mr. Griffith showed the Board morning news and great video clips from the television studio. He said the studio is really thriving and said Mrs. Maione is doing a great job.

The proposed budget includes sufficient fund to provide curriculum and instruction which will enable all students to achieve the Core Curriculum Contents Standards, as is in compliance with N.J.S.A. 18A and N.J.A.C. Title 6 and 6A.
