# EGG HARBOR CITY BOARD OF EDUCATION REGULAR MEETING

March 9, 2016

The regular meeting of the Egg Harbor City Board of Education was held on the above date at 7:00 p.m. at the Egg Harbor City Community School, 730 Havana Avenue, Egg Harbor City, New Jersey, with Board President, Stephen Bouchard opening the meeting, and board members, Janine Brown, Carmen Filippello, Stephen Murphy, Steven Ortiz, MaryAnn Rogers and Jeanne Williams present. Also present was: Superintendent/CLS Principal, Adrienne Shulby; Business Administrator, Joseph Smurlo; Supervisor of Special Projects, Gina Forester; Supervisor of Early Childhood/LDTC, Tara Macchione; Board Solicitor, Ron Sahli and Board Secretary, Laura E. Quiñones.

Mr. Bouchard called the meeting to order at 7:00 p.m. with the following statement: This is to advise those present at this meeting of the Board of Education of the Egg Harbor City School District, in the County of Atlantic, that adequate notice has been given of this meeting as required by the provision of Chapter 231 of the Laws of 1975; that notice thereof has been forwarded for publication in the District official newspapers, posted in the city Schools, and forwarded to the city Clerk within the time required by said Act.

Mr. Bouchard called for the flag salute and roll call, which is reflected in the opening paragraph.

#### OPEN FLOOR TO THE PUBLIC

Mr. Bouchard invited the public to comment on or question any topic related to the Board of Education agenda items. No public comments were made.

# COMMENTS FOR THE GOOD OF THE BOARD

Mr. Bouchard commented on the Green House Ribbon Cutting Ceremony. He acknowledged the efforts of Mr. Griffith and the staff for their participation in offering this opportunity to the students. There were two articles in the paper regarding this ceremony.

#### MONTHLY REPORTS

Mrs. Shulby reports that the school has met with representatives from the Coalition for A Safe Community-West. Mr. Griffith is in attendance at a meeting with the coalition tonight and therefore is not at this meeting. Mrs. Shulby, on behalf of Mr. Griffith, informed those present that the Community School was named National Recycling School of the Year. The Spragg School was ranked at #5. Mrs. Shulby congratulated Mr. Griffith and the staff for this achievement.

Mr. Smurlo reports that under the Financial Items section of the Agenda, the board will be asked to approve submission of the tentative budget to the County Office of Education. The school district received an additional \$40,000 this year. The PK aide will continue this year. No cuts will be made and \$40,000 will go into the capital reserve account. Tax levy will remain the same as last year with no increase.

Dr. Forester reports that during the last 2 years, a group of teachers have been trained with the formative assessment. First session was in October and session two was in February. The teachers are doing a fantastic job with this information. Dr. Forester noted during this past round of teacher evaluations that the teachers are including formative assessments tools into their classroom practices. Dr. Forester thanks all those who are participating and states they are doing a phenomenal job.

Mrs. Macchione reports that last week there were activities for Read Across America Day. Guest readers came in to read to the students and the police department also participated.
