EGG HARBOR CITY BOARD OF EDUCATION REGULAR MEETING

April 13, 2011

The regular meeting of the Egg Harbor City Board of Education was held on the above date at 5:30 p.m. at the Egg Harbor City Community School, 730 Havana Avenue, Egg Harbor City, New Jersey, with President Stephen Bouchard opening the meeting, and board members, Richard Dovey, Joseph Farnan, Dan McGinnis, Scott Senn, and Jeanne Williams present. Also present were: Superintendent, John Gilly III; Business Administrator, Joseph Smurlo; Supervisor of Special Projects, Gina Forester; Spragg Principal, Adrienne Shulby; Community School Principal, Jack Griffith; and, Board Secretary, Marie Setterman.

MONTHLY REPORTS

Mr. Gilly reported that he had received a letter from Christopher Cerf, Acting Commission of Education regarding the district performance review of the Quality Single Accountability Continuum (QSAC). Mr. Gilly gave the board a copy of the letter which included complete DPR results, county office verification of the district's self-assessment and placement scores as follows:

Mr. Gilly said that since the district did not satisfy at least 80% of the weighted indicators in the area of instruction and program, the district will need to complete a District Improvement Plan (DIP) detailing the district's strategies for improvement in this area and a long term plan (LTP). The DIP is due to the DOE by June 1, 2011 and the LTP is due by October 1, 2011.

Mr. Gilly gave the Board an overview of the new NJ Harassment, Intimidation and Bullying (HIB) law which will become effective September 2011. Major changes include the HIB definition, district staff functions, policy and procedures, programs, training requirements and public reporting.

Mr. Smurlo reported that he is currently getting ready for the election. He also reported that he had received a total of 29 proposals for the RFP requests regarding architect, attorney, auditor and insurance broker.

Mrs. Forester reported that all ESL students had been tested at the end of March using the Access for ELS test.

Mrs. Shulby said that CLS instituted March Multiplication Madness including an awards assembly. She said the program was well received.

Mr. Sahli arrived at 8:05 p.m.

Mr. Griffith reported that EHCCS will be using a new program called Study Island. Study Island is an online assessment tool/supplemental and remedial instruction program geared to assist students to master common core standards in math and LAL. Mr. Griffith said students will be able to sign on at home to do their work.
