# EGG HARBOR CITY BOARD OF EDUCATION REGULAR MEETING

October 14, 2015

The regular meeting of the Egg Harbor City Board of Education was held on the above date at 7:00 p.m. at the Egg Harbor City Community School located at 730 Havana Avenue, Egg Harbor City, New Jersey, with President Janine Brown opening the meeting, and board members, Stephen Bouchard, Carmen Filippello, Julie Hall, Stephen Murphy, Steven Ortiz and Jeanne Williams present. Also present were: Superintendent/CLS Principal, Adrienne Shulby; Business Administrator, Joseph Smurlo; Community School Principal, John Griffith; Supervisor of Early Childhood/LDTC, Tara Macchione; Board Solicitor, Ron Sahli and Board Secretary, Laura E. Quiñones.

Ms. Brown called the meeting to order at 7:00 p.m. with the following statement:

Ms. Brown called for the flag salute and roll call, which is reflected in the opening paragraph.

# **AWARD PRESENTATIONS**

On behalf of the board and administration Mrs. Shulby recognized and congratulated Mr. Dominick Grossi on his retirement. Mrs. Shulby stated that Mr. Grossi was a team player and that the school was fortunate of have had him on staff. He always had a positive attitude which contributed to his student's success. The staff at CLS wanted him to know that he is and will be missed.

Mr. Grossi told a short story as to how he came to work at the Egg Harbor City Schools. He thanked everyone for the opportunity and was appreciative of the years he has taught at CLS. He also thanked everyone for the retirement gift presented to him.

Mrs. Shulby then presented Mr. Paul McIntyre and Commander Mishclich of the American Legion Rudolph Elmer Post 158. Mr. McIntyre presented an award that will be given to Perry Parker (not present), winner of the Atlantic County American Legion Coloring Contest, for his drawing of the Stone Harbor Lighthouse. He stated that every year the students are given a theme which they research in order to do their drawing. Perry will also be given an award of \$50.
