EGG HARBOR CITY BOARD OF EDUCATION REGULAR MEETING

February 12, 2020

The regular meeting of the Egg Harbor City Board of Education was held on the above date at 7:00 p.m. at the Egg Harbor City Community School, 730 Havana Avenue, Egg Harbor City, New Jersey, with President, Stephen Bouchard opening the meeting, and board members, Janine Caudo, Kiomy Fuentes, James Guercioni, Stephen Murphy, MaryAnn Rogers and Dana Seaver present. Also present was: Superintendent/CLS Principal, Adrienne Shulby; Business Administrator, Joseph Smurlo; Community School Principal, John Griffith; Supervisor of Special Projects, Gina Forester; Supervisor of Early Childhood/LDTC, Tara Macchione; Board Solicitor, Ron Sahli and Board Secretary, Maryanne Shupin.

Mr. Bouchard called the meeting to order at 7:00 p.m. with the following statement: This is to advise those present at this meeting of the Board of Education of the Egg Harbor City School District, in the County of Atlantic, that adequate notice has been given of this meeting as required by the provision of Chapter 231 of the Laws of 1975; that notice thereof has been forwarded for publication in the District official newspapers, posted in the city Schools, and forwarded to the city Clerk within the time required by said Act.

The Board values and welcomes comments and opinions from residents as long as remarks are not personal or discourteous. The public comment portion of the meeting allows the Board to listen to community members and to hear their opinions on school policy and operations.

There are two opportunities to address the Board. The first public portion is reserved for persons wishing to speak about agenda items only. The second opportunity, following the action items, residents may address the Board on any school related issue. Once identified, a speaker is asked to limit their comments to three minutes. Yielding time is not permitted. The public comments portion of the meeting will not exceed 30 minutes total.

Mr. Bouchard called for the flag salute.

STAFF RECOGNITION

Mrs. Shulby introduced Danielle Broomhead as Charles L. Spragg's 2020 Teacher of the Year. Mrs. Broomhead started teaching in Egg Harbor City in 2015. Originally, Mrs. Broomhead taught at the Community School but teaching younger students was her passion. Mrs. Shulby shared it is a blessing every day to have Mrs. Broomhead at the Spragg School. Mrs. Broomhead was nominated by her colleagues for being humble and for working tirelessly. Mrs. Shulby echoed Mrs. Broomhead works every day to meet the needs of every single one of her students.

Mrs. Broomhead thanked the Board and Administration for the opportunity to teach at Egg Harbor City. She also thanked her family, especially her husband, for all the support they provided all day every day.

Mr. Griffith introduced Matthew Wira as Egg Harbor City Community School's 2020 Teacher of the Year. Mr. Wira was hired as an In-Class Resource Teacher; however, it became obvious that he possessed the skill to connect with children that made it was clear he needed a classroom of his own. Mr. Wira teaches a Self-Contained Special Education multi-grade class. Mr. Wira was overwhelmingly nominated by his peers. Mr. Wira has the ability to take a difficult task and make it look easy. One former-at risk student, was able to identify that she was treasured, respected and safe in Mr. Wira's classroom that she called them "Family". This student graduated high school and went on to college.

Mr. Wira noted that it's easy to speak to children than adults. He recalled the moment he accepted the position at the Community School and said the longer he is here the more he wants to be involved in this great Community. He thanked the Board for this awesome opportunity.

Mrs. Shulby informed the Board both Mrs. Broomhead and Mr. Wira have applied to be Governor's Educator of the Year. Both will be recognized at a luncheon in the spring.

Mr. Bouchard and the Board congratulated and thanked both teachers for all of their support for Egg Harbor City.
